He/she accepts to see to the well-being of the minors listed above from the moment they have access to the establishment, he/she shall remain with them throughout the entire performance and they shall leave the premises once the performance has finished. He/she shall make sure that the minor(s) have a personal ID document with them at all times.

Because of this, he/she assumes the responsibility of preventing the minor(s) from consuming substances such as alcohol, tobacco or drugs and to avoid situations of risk or danger for the minor(s) or those that said minors may cause.

He/she accepts to release the establishment from liability for any harm, damage or disorder that said minor(s) may suffer or cause during their stay at the establishment.

He/she firmly consents to the establishment not refunding the price paid by the minor(s) or refusing their entry if they have not met any of the preceding conditions or if they have not provided the correct documentation that is required.

The non-fulfilment of any of the foregoing particulars may entail the removal from the establishment of the person signing this authorisation and/or of the individuals under his/her care.

Public Shows and Recreational Activities Act (Act 17/1997, of 4 July)
Article 25. Protection of Minors

Section 1: Minors below the age of 18 are generally forbidden from entering and remaining in special bars, as well as in discotheques and similar establishments where alcoholic beverages are sold or offered, except when live performances take place, in which case minors below the age of sixteen must be accompanied by their parents or guardians.

At the end of the performance the minors are not to remain in the establishment.

In compliance with Basic Law 15/1999, of 13 December, on the Protection of Personal Data (LOPD), you are informed that the personal data that have been provided will be included in the file whose holder and controller is , with the sole purpose of managing and controlling the access of minors to the facilities.
